

Privacy Notice – Quality Alerts

A Quality Alert is a systemic issue, generally affecting a service, or the ability to deliver a high quality service. The system has been established to enable GPs and other colleagues within Primary Care to report issues relating to quality and patient safety to providers using the Quality Alert System. The CCG's Quality Team will receive a copy of the quality alert as part of their surveillance system.

The CCG has a statutory duty to support NHS England with the continuous quality improvement of primary medical services as set out in the Health and Social Care Act 2012 and the Primary Medical Services assurance framework.

In order for the CCG to triage quality alerts and incidents reported by GPs and providers, the Quality team at the CCG may require the relevant individual's NHS number in order to investigate the quality alert or incident.
